WHEREAS, the United States has made considerable progress in the social, technological and scientific fields due to our system of free and universal public education, and

WHEREAS, teachers should be accorded high public esteem, reflecting the value the community places on public education, and

GRADUATION REQUIREMENTS

1. A high school diploma will be granted to students enrolled in Marietta High School who complete the following requirements:
 - a. Seniors who have met all graduation requirements **except** passage of the state mandated Ohio Graduation Test may participate in the graduation ceremony exercise. The diploma for that student will not be issued until such time that the state mandated Ohio Graduation Test is passed (all required sections).

- b. Earn the following number of academic credits or Carnegie units as indicated. Career Center students may have other specific requirements depending upon the program in which they are enrolled.

2. Students below the 9th grade may earn credit toward high school graduation requirements by taking advanced course work providing:
- The course is taught by a person who possesses a license or certificate issued by the Ohio Department of Education that is valid for teaching high school, and
 - The curriculum for the course has been approved by the Marietta City Schools Board of Education as meeting the high school curriculum requirements.
3. Diploma With Honors: Those graduates who meet the requirements established by the State Board of Education will be awarded a “Diploma With Honors.”

4. **Special Recognition:** Effective with the graduating Class of 2009, students must earn a minimum of four (4) Carnegie units during each of their junior and senior years through courses taken and completed at Marietta High School or at the Washington County Career Center in order to be eligible for selection as valedictorian, salutatorian, or National Honor Society.
5. **Alternative Graduation Requirement:** To earn a diploma without completing the CORE curriculum (Class of 2014 & beyond), the requirements are as follows:
 - The student must complete two years of high school and the student's parent must sign a statement consenting to the child's graduation without completing the CORE and acknowledging that the child may not be able to proceed directly to a four-year university.
 - The student and parent, guardian, or custodian must fulfill any procedural requirements the school stipulates to ensure the student and parent, guardian, or custodian are informed of the informal consent process.
 - The student, the parent and the high school must develop a career plan for the child.
 - The student's high school must provide counseling and support for the student related to the plan.
 - The student successfully completes, at a minimum, the curriculum prescribed in the current law. See requirements for the Class of 2009 – 2013 on page 1 of this policy.
6. **Summer School:** Summer school credits are accepted toward graduation provided that administrative approval has been given prior to registration for the course.
7. **Correspondence Courses:** High school courses offered through correspondence courses are accepted for credit toward graduation only when they meet the following criteria.
 - Credits earned in correspondence schools directly affiliated with state universities are evaluated by the school administration for students who wish to qualify for graduation from high school.
 - Credits earned from correspondence schools not directly affiliated with an accredited college or university may not be applied toward graduation.
 - Credits earned from schools, which have been established primarily for correspondence study, rather than an institution primarily for residence study, are not accepted toward graduation.
8. **Community Service:** The District offers community service education which acquaints students with the history and importance of volunteer service and with a wide range of existing community needs. Community service opportunities may be considered an elective towards graduation.

Res. #2011-89 Mr. Hutchinson made a motion and Mrs. Myers seconded the motion
to approve the following resolution.

2h WHEREAS, the Ohio House of Representative is currently considering legislation that would significantly expand the availability of vouchers for students to attend private or parochial schools, and

WHEREAS, this legislation would grant vouchers to any public school student in Ohio to request and be granted a voucher, subject only to a family income standard of \$95,000 or less, and

WHEREAS, such vouchers would be granted without regard to the academic performance of the public school that the student is assigned to attend, and

WHEREAS, the bill provides that students already enrolled in private or parochial schools would be eligible for such vouchers, and

WHEREAS, students receiving vouchers would be able to retain any excess funds in those instances where the cost of tuition is less than the value of the voucher for use in any private school or college in Ohio, and

WHEREAS, the operation of the proposed program would take dollars directly from the already financially beleaguered local public school districts resulting in fewer resources for the education of the remaining students;

NOW THEREFORE, BE IT RESOLVED, that the Marietta City Schools Board of Education does hereby express its opposition to this legislation, HB 136 School Choice, and

BE IT FURTHER RESOLVED, that the Marietta City Schools Board of Education expresses its opposition to any legislation that seeks to transfer public dollars to support private education, and

BE IT FURTHER RESOLVED, that the Treasurer be directed to spread this resolution upon the minutes of the Board of Education and that copies of the resolution be forwarded to members of the Ohio House of Representatives.
